Fire Chief, Andy Thiessen, presented before Council a budgetary surprise related to Honeywell's rescinded certification of the current breathing apparatus. This sparked concerns about equipment functionality and the need for costly replacements. Discussion focused on finding alternative suppliers. Detailed comparisons of equipment options, financial planning, and resource allocation were explored, emphasizing the urgency of replacing the non-compliant equipment while balancing cost considerations. Council recommended the purchase of MSA fire breathing equipment thru Reliant Action Seal Safety Solutions amounting to \$ 189, 052.50 being an approved vendor thru the Canoe Procurement Program.
